This milestone was especially enjoyed this spring during ARVO's Annual Meeting, held in Fort Lauderdale, Florida and attended by more than 8,200 people. Considering the world events that affected us all, I am thrilled participation increased from last year and that so many of you were able to join us for a week full of innovative science, state-of-the-art technology and research product exhibits, networking with friends and colleagues both in academic and social settings, interesting lectures, and fun social events.

I thank those who attended, presented, exhibited, and supported us during the Annual Meeting. The scientific program offered this year did not disappoint and we have already begun to plan for the 2004 Annual Meeting, the theme of which will be "The Site for Sight." I'm looking forward to seeing you April 25-29, 2004 in Fort Lauderdale.

With autumn fast approaching, I would like to take a moment and share with you important information pertaining to your Membership, particularly regarding ARVO's Strategic Plan and two Bylaws amendments.

#### As you know, the Association for Research in Vision and Ophthalmology (ARVO) is celebrating its 75th anniversary this year,

**Bylaws** 

At their meeting in June 2003, the Board of Trustees passed one procedural amendment to the ARVO Bylaws. This amendment changed the requirement that a Section must nominate two individuals to appear on the ballot when that Section is electing a Trustee. The Bylaws now read that a Section may nominate no more than two individuals for the position of successor trustee. While this means that a Section may, in fact, nominate only one individual to appear on the ballot unopposed, the Board made it clear that it did not endorse this practice. Whenever possible, Sections are encouraged to recruit two nominees to run for election when the time comes for the Section to choose its next trustee.

At the same meeting, the Board also approved one amendment regarding Emeritus Membership that will be voted on at the 2004 General Business Meeting. At the General Business Meeting, the voting members of

ARVO will cast ballots on an amendment to remove age as criteria for Emeritus Membership. In accepting this amendment, the Board expressed its opinion that the stated age of 65 was too arbitrary, as many individuals work well past this age, and the setting of any age would be haphazard at best. The wording of the amendment establishes the requirements for Emeritus membership as having been a regular member of ARVO for at least 10 consecutive years and no longer actively engaged in vision research.

# Elections

## New Trustees 2003–2009

At its Annual Meeting in Fort Lauderdale, The Association for Research in Vision and Ophthalmology (ARVO) announced the election of new Trustees from the Anatomy & Physiology (AP) and Glaucoma (GL) Sections, as well as the President-Elect and Vice President-Elect for the coming year.

#### Robert Ritch, MD

from the New York Eye and Ear Infirmary was elected to a five-year term as GL Trustee, assuming the office previously held by Robert Weinreb, MD of UC San Diego.

Dr. Ritch is Surgeon Director and Chief of Glaucoma Services at the New York Eye & Ear Infirmary, New York City and Professor of Clinical Ophthalmology at The New York Medical College, Valhalla, New York. He has devoted his career to broadening the understanding of the nature of glaucoma and innovation in the medical, laser, and surgical treatment of glaucoma. Dr. Ritch has been a member of ARVO since 1977 and has served on its Program Committee. He is also active in the American Academy of Ophthalmology, serves on an Advisory Committee of the International Council of Ophthalmology, and the Program Committee of the American Ophthalmological Society. His research interests include ocular imaging, angle closure, glaucoma, and secondary glaucoma.

#### Martine Jager, MD,

PhD from Leiden University in The Netherlands was elected to a five-year term as AP Trustee, assuming the office previously held by Edward Howes, MD of UC San Francisco.

Dr. Jager is head of the laboratory of Immuno-Ophthalmology, in the Department of Ophthalmology, Leiden University Medical Center, Leiden, The Netherlands. She has been an ARVO Member since 1990 and has also served on the ARVO Program Committee. Dr. Jager is a member of the American Academy of Ophthalmology, the Dutch and British Societies of Immunology, and serves on the Ophthalmic Oncology Task Force. Her research interests include uveal melanoma, ocular immunology (corneal transplantation, herpes, ocular immune privilege), and ocular surface diseases.

#### **Officers Elected**

The Board of Trustees elected Gary Abrams, MD from Wayne State University to the office of President-Elect, and Thomas Yorio, PhD from the University of North Texas as Vice President-Elect.

#### **Trustees Nominated**

Members of the Visual Psychophysics & Physiological Optics (VI), Retinal Cell Biology (RC), and Immunology & Microbiology (IM) Sections nominated successor Trustees for election at the 2004 Business Meetings of those particular Sections. Nominated were; from VI, Donald Hood, PhD and Janette Atkinson, PhD; from RC, Barry Winkler, PhD and John Penn, PhD; and from IM, Todd Margolis, MD, PhD.

The ARVO Board of Trustees has over-all responsibility for the business and affairs of ARVO. It consists of one elected Trustee from each of the 13 Scientific Sections that constitute the Association. The Board ensures that all ARVO sponsored or supported activities are consistent with the Association's mission to promote and support eye and vision research. The Board sets policy; monitors the activities of the committees and interest groups; interacts with other organizations; and develops an annual budget and allocates Association resources.

#### Committee Upclates Advocacy

In addition to monitoring issues in the US Congress related to the National Eye Institute (NEI) budget and research regulation, the Committee is planning its second "International Public Policy and Research Advocacy Symposium," scheduled for April 26, 2004, at the ARVO Annual Meeting. A summary of presentations from the first symposium are available at www.arvo.org/ committee/advocacy/advocacy.asp. This is an important element in successfully achieving the Committee's larger goal of broadening the scope of ARVO's advocacy activities to support members outside the US.

#### Animals in Research

In June 2003, the Committee provided comment on proposed USDA guidelines for the maintenance of medical records for animals used in laboratory research. A copy of this comment can be found at www.arvo.org/committee/ animalsinresearch/animalreseach.asp. The Committee is planning an exciting workshop for the 2004 Annual Meeting entitled, "Practical Issues in the Use of Animal Models." This workshop is scheduled for Monday, April 26. ARVO President, Sally Atherton, PhD, has approved the ARC Chair, Jeffrey Kiel, PhD to be the ARVO representative to the Association for Assessment and Accreditation of Laboratory Animal Care International replacing Maureen Powers, PhD, whose term expired.

#### **Commercial Relationships**

Building on the interest and success of their 2003 workshop on this topic, the Committee will again host a workshop at the 2004 Annual Meeting on the issue of intellectual property. This year's workshop will focus on working with a tech-transfer office and the impact of market forces. This workshop is scheduled for April 27.

#### **Diversity**

In planning its workshop for the 2004 Annual Meeting, scheduled for April 25, the Committee is working with the International Members Committee to address "The Trials and Tribulations of International Scientists." This workshop will focus on the hurdles international researchers face relating to training, funding, and travel.

Each year, a Subcommittee of the Diversity Issues Committee coordinates a program to educate local high school students about the importance of research by providing educational seminars and tours of the ARVO meeting. These students are a diverse group; bright, motivated and interested in science and health care professions. You can show your support by giving tours of the Meeting for 90 minutes on Tuesday morning April 27, 2004. For more information, please contact the High School Education coordinator, Jeffrey J. #### **Ethics and Regulations for Clinical Research**

The Committee will address the issue of "Privacy Rights and HIPAA Regulations: Impact on Human Research" in its workshop, scheduled for April 25 at the Annual Meeting. In planning for this workshop, the Committee will be collecting data from ARVO members regarding the impact of HIPAA in their institutions. Please watch for this survey in the coming weeks.

#### **International Members**

The Committee continues to monitor the changing regulations governing the

issuance of travel visas for international researchers traveling to the US (see page 7). The Committee is also working to secure additional travel grants for international members presenting at the ARVO Annual Meeting.

#### Members-in-Training

Each year, the Committee hosts a number of events at the annual meeting for students, post-docs, and fellows including a Career Fair, Networking Reception, Pizza with a Prof, and a workshop dealing with career planning issues and opportunities. See the Annual Meeting *Program Summary* Book (mailed in March) for a full schedule of 2004 activities.

#### Long Range Planning

## Workshop Helps Members Understand NIH Peer Review

The National Institutes of Health (NIH) may appear to work in mysterious way, but ARVO members who attended the NIH Grants Workshop at the 2003 Annual Meeting know better.

Staff from the NIH's Center for Scientific Review (CSR) conducted the workshop to help ARVO members understand what happens to their grant application after it is mailed.

The workshop began with an introductory presentation that explained the role of the CSR in the peer review process. The remainder of the workshop consisted of a mock study-section meeting.

After a grant application is received by the NIH, a CSR Referral Officer assigns the application to the study section best qualified to review its content. Prior to the meeting of the study section, two or more reviewers are assigned to read the application in detail and provide written comments. During the study section meeting, the primary reviewers elaborate on their comments and their entire group is permitted to discuss and score the application. After the application is reviewed and is scored by the study section, it leaves the CSR and is forwarded to a Program Officer at an NIH Institute or Center (such as the National Eye Institute) where the eventual decision about funding is made.

December 7, 2003 at 11:59 PM EST is the latest you can revise an abstract. NOTE: An abstract must be completed by the December 5 deadline in order to revise through December 7. ARVO staff will not revise or correct abstracts.

Only an ARVO member can be a First Author on an abstract. A non-member cannot be a First Author on an abstract. You can become an ARVO member online at www.arvo.org. First Authors and all co-authors must disclose all commercial relationships at the time of submission and presentation. You must indicate the appropriate commerical relationship

code and the name of any firms that correspond to the codes indicated. Paper presenters must indicate this information on a slide at the time of presentation, and poster presenters must include this information on their poster.

#### **Online Abstract Search** and Program Planner

The Online Abstract Search and Program Planner, available after February 23, 2004 at www.arvo.org, will include a searchable database of authors, titles, full text of abstracts, and other program information. This program will again include searching capabilities, multiple abstract printing options including full sessions in PDF format, and a link to purchase a Print-on-Demand Abstract Book. Again available this year, your Meeting itinerary can be downloaded to a Personal Data Assistant.

#### **Program Summary** Book and CD-ROM

The CD-ROM, both PC and Mac compatible, will feature enhanced loading and speed to provide more efficient use and data access. In addition, similar to the online program, there will be advanced searching capabilities, multiple abstract printing options, including full sessions in PDF format, and a link to purchase a Print-on-Demand Abstract Book. The Program Summary Book and CD-ROM will mail together in early March and delivery can take up to six weeks. ## Meeting New Visa Requirements May

## Impact Annual Meeting Travel

Earlier this year, the United States Department of State enacted new procedures that will impact many international attendees to the ARVO Annual Meeting. Visa applications are now subject to a greater degree of scrutiny than in the past. For many applicants, a personal appearance interview is required as a standard part of visa processing, even where one may not have been required before. Applicants affected by these procedures will be informed of the need for additional screening at the time they submit their applications and should expect delays. The time needed for adjudication of individual cases will continue to be difficult to predict. The need for an interview will mean additional coordination with the embassy or consulate in order to schedule an interview appointment.

Additionally, travelers from countries that participate in the Visa Waiver Program should be aware of a new rule requiring that passports be machinereadable. Citizens of 27 countries can visit the US for up to 90 days without a visa—and the courtesy is returned to US citizens visiting those nations. The Visa Waiver Program applies to the nations of: Western Europe; Slovenia; Australia; New Zealand; Japan; Brunei; and Singapore. However, The Washington Post reports that as of October 1, 2003, visitors from those countries will be turned away unless their passport is electronically coded. Examples of the enforcement of this new rule include the denial of entry for travelers without visas from Belgium, whose passports US officials consider easy to counterfeit and for the half of all French passports that are not machine-readable.

ARVO recommends that all members begin the process now to determine the individual requirements that will impact travel planning for the 2004 Annual Meeting attendance and to begin the visa application process if necessary. ## Advocacy NEI Remains Independent Amidst NIH Change

A report prepared and released by a Special Committee of the National Research Council and the Institute of Medicine, at the request of Congress, advised that the National Institutes of Health (NIH) should combine some functions and focus more on interdisciplinary work. The hope is this will allow NIH to address concerns that it has become fragmented and hard to manage.

It was also recommended that the National Institute on Drug Abuse be combined with the National Institute on Alcohol Abuse and Alcoholism, and the National Institute of General Medical Sciences merge with the National Human Genome Research Institute. However, the panel stated a wholesale consolidation of institutes and centers is unnecessary because it would be costly, could slow decision-making and there are other ways to improve coordination within the NIH.

This is a victory for the National Alliance for Eye and Vision Research (NAEVER) and ARVO, both of whom advocated vigorously for the independence of the National Eye Institute (NEI) and voiced opposition to the proposed folding of NEI into a broader neuroscience institute.

NAEVR past Executive Director, Ed McManus, organized a coalition of more than 20 organizations, most of whom were outside the eye and vision community to present the argument for preserving the independent institutes that make up the NIH. ARVO members **Karla Zadnik**, OD, PhD and **Marco Zarbin**, MD joined McManus in presenting testimony before the Committee.

## **NEI Budget Update**

After a long and contentious budget process, the NEI received an appropriation in FY 2003 of \$633.1 million, an increase of \$53.1 million or 9.2 percent compared to FY 2002. The NIH as a whole received \$27.0 billion, an

increase of \$3.5 billion or 14.9 percent, compared to FY 2002. While the NIH increase nearly completed the goal undertaken by Congress in 1998 of doubling the NIH budget in five years, NEI's increase over the same period was approximately 85 percent.

The FY 2004 Budget is still working its way through the halls of Congress. The Administration requested a budget of \$648.3 million for the NEI, an increase of \$15.2 million or 2.4 percent over FY 2003. For NIH, the Administration requested \$27.9 billion, an increase of \$0.9 billion or 3.4 percent. On July 10, 2003, the House narrowly passed the FY 2004 Labor/HHS appropriation bill by a vote of 215 to 208 without Democratic support. The House bill would provide funding identical to the Administration's FY 2004 budget request described above. The Senate Appropriations Committee completed its mark up of the FY 2004 appropriation bill on June 26, 2003. This bill would provide \$657.2 million for the NEI, an increase of \$24.1 million or 3.8 percent compared to FY 2003, and \$28.1 billion for NIH, equal to a \$1.1 billion increase, or 4.1 percent. At press time, the full Senate had yet to take up the Labor/HHS appropriations bill where action is expected to be contentious, particularly in regards to funding for the Department of Education, which is also included in the massive bill.

#### National Eye Institute

The Committee's report called for Congress to fund a new program for special projects that would be managed from the NIH director's office. "Despite our conclusion that widespread consolidation of the institutes and centers would be unwise now, we do not expect NIH's organizational structure to remain frozen," committee chair Harold T. Shapiro, a Princeton University professor of economics and public affairs, said in a statement. "We are convinced that many of the goals that might be achieved through large-scale consolidation could be achieved more rapidly and effectively through other organizational mechanisms."

The panel recommended a six-year term for the NIH director and five-year terms for heads of institutes and centers. Currently there are no term limits. Authority to hire and dismiss heads of institutes and centers should be transferred from the Health and Human Services secretary to the NIH director was also recommended by the panel.

In addition to these two new programs, NEI will continue to support its four existing programs: NEI Small Research Grants for Data Analysis (R03), NEI Small Grants for Pilot Research (R03), NEI Clinical Study Planning Grants (R21), and NEI Clinical Vision Research Development Awards (R21). These applications will continue to be reviewed in study sections organized by the NEI.

These six grant programs vary considerably in scientific purpose, the years of support and dollar level provided, the nature and length of the application, and the locus of peer review. Applicants should consult the NEI Web site (Research Funding) at **www.nei.nih.gov**, to determine which program best meets their specific needs. - Keynote speakers Elias A. Zerhouni, MD, director of the National Institutes of Health, and Paul A. Sieving, MD, PhD, director of the NEI.
- Awards to Congressional champions of vision research, including Senator Tom Harkin (D-IA) and Representative Michael Capuano (D-MA).

Since THE EYE SITE tour was launched in April 2001, the NEI has:

- Provided more than 25 million people in 20 states and the District of Columbia with the opportunity to visit the exhibit and learn about low vision.
- Distributed more than 45,000 publications.
- Worked with more than 65 vision-related host organizations.

#### NIH Programs Repay Student Loans for Health Researchers

The National Institutes of Health (NIH) Loan Repayment Programs offer up to \$35,000 per year to repay student loans of scientists, physicians, dentists, and other health professionals willing to commit to a career in clinical, pediatric, health disparities or contraception and infertility research. Applicants must have doctoral-level degrees and commit to spend at least 50 percent of their time for two years conducting qualified research.

The online application opens September 1 and closes December 31, 2003.

## Journal of Vision is Growing!

#### How does ISI Calculate Impact Factor?

The 2002 Impact Factor is based on cites in 2002 to articles published in 2001 (1,737 articles) and 2000 (2,567 articles) for a total of 4,304 articles, divided by the number of articles published by *IOVS* in those two years (470 in 2001, 582 in 2000) yielding a total of 1,052. Therefore, 4304/1052 = 4.091.
